grand strategy to end the cold war wilson paints a vivid portrait of how leaders made choices some made poor choices while others reacted prudently imaginatively and courageously to events they did not foresee a book about the burdens of responsibility the obstacles of domestic politics and the human qualities of leadership the triumph of improvisation concludes with a chapter describing how george h w bush oversaw the construction of a new configuration of power after the fall of the berlin wall one that resolved the fundamental components of the cold war on washington s terms
