tenth and eleventh centuries in medieval europe are commonly seen as a time of uncertainty and loss an age of lawless aristocrats of weak political authority of cultural decline and dissolute monks and of rampant superstition it is a period often judged from its margins compared mostly negatively to what came before and what would follow we impose upon it both a sense of nostalgia and a teleology as they somehow knowingly foreshadow what is to come seeking to complicate this

mischaracterisation which is primarily the invention of nineteenth and early twentieth century historiography this book maps the movement between two intellectual stances a shift from prophetic to apocalyptic thinking although the roots of this change lay in late antiquity the fulcrum of this transition lies in the tenth and eleventh centuries biblical commentators in the fourth and fifth centuries enforced a particular understanding of sacred time that held until the ninth century when exegetes of the ninth century found in their commentaries a different plan for god's new chosen people this came into stark relief as the new kingdom of israel the frankish empire under the carolingians had splintered in the 840s god was manifesting his displeasure with the chosen people by fire and sword what was perhaps unforeseen was that these commentaries that were written in the specific context of the carolingian civil war would be heavily copied and read for the next 200 years ideas that formed in a world that actively lamented the loss of empire had to be translated to a world that could only dream of that empire as they spread across europe these ideas became the basis for monastic educational practices and bled into other types of textual production such as supposedly secular histories between prophecy and apocalypse charts an intellectual transformation triggered when the prescriptions laid out towards the end of the carolingian empire began to be realized in subsequent centuries nostalgia entwined with an attentiveness to possible futures and spun together so tightly as to become a double helix ultimately this book will offer a way to understand the central middle ages a period of dynamic intellectual ferment when ideas could inspire action and seemingly banal conceptions of time and history could inspire moments of dramatic transformation and horrific violence

emotions in a crusading context is the first book length study of the emotional rhetoric of crusading it investigates the ways in which a number of emotions and affective displays primarily fear anger and weeping were understood represented and utilized in twelfth and thirteenth century western narratives of the crusades making use of a broad range of comparative material to gauge the distinctiveness of those texts crusader letters papal encyclicals model sermons chansons de geste lyrics and an array of theological and philosophical treatises in addition to charting continuities and changes over time in the emotional landscape of crusading this study identifies the underlying influences which shaped how medieval authors represented and used emotions analyzes the passions crusade participants were expected to embrace and reject and assesses whether the idea of crusading created a profoundly new set of attitudes towards emotions emotions in a crusading context calls on scholars of the crusades to reject the traditional methodological approach of taking the emotional descriptions embedded within historical narratives as straightforward reflections of protagonists lived feelings and in so doing challenges the long historiographical tradition of reconstructing participants beliefs and experiences from these texts within the history of emotions stephen j spencer demonstrates that despite the ongoing drive to develop new methodologies for studying the emotional standards of the past typified by experiments in neurohistory the social constructionist or cultural historical approach still has much to offer the historian of medieval emotions explicating clearly and concisely the full implication of a praxis oriented language pedagogy this book argues for an approach to language teaching grounded in a significant scientific theory of human learning a stance that rejects the consumer approach to theory and the dichotomy between theory and practice that dominates sla and language teaching this approach is based on vygotsky s sociocultural theory according to which the two activities are inherently connected so that each is necessarily rooted in the other practice is the research laboratory where the theory is tested from the perspective of language education this is what is meant by the pedagogical imperative sociocultural theory and the pedagogical imperative in l2 education elaborates a new approach to dealing with the relationship between theory and practice an approach grounded in praxis the dialectical unity of theory and practice presents an analysis of empirical research illustrating praxis based principles in real language classrooms brings together cognitive linguistics and sociocultural theory the former provides the theoretical knowledge of language required of praxis and the latter furnishes the theoretical principles of learning and development also called for in a praxis approach offers recommendations for redesigning teacher education programs its timely focus on the theory practice gap in language education and its original approach to bridging it put this book at the cutting edge of thinking about vygotskian sociocultural theory in applied linguistics and sla this is the first english translation of robert the monk s historia iherosolimitana a latin prose chronicle describing the first crusade in addition to providing new and unique information on the crusade robert claims to have been an eyewitness of the council of clermont in 1095 its particular interest lies in the great popularity it enjoyed in the middle ages the text has close links with the vernacular literary tradition and is written in a racy style which would not disgrace a modern tabloid journalist its reflection of contemporary legends and anecdotes gives us insights into perceptions of the crusade at that time and opens up interesting perspectives onto the relationship of history and fiction in the twelfth century the introduction discusses what we know about robert his importance as a historical source and his place in the literary tradition of the first crusade the folklore of texas big bend region was still in the making during walter fulcher s lifetime born in lampasas county in 1887 he worked on the martin ranch near sheffield when a young man there he witnessed events in the last outlaw activities of the black jack ketchum gang he also listened to legends told almost as gossip and some of the legendary figures were still alive or said to be alive usually in hiding in every village there was sure to be some ancient with a good memory and a better imagination and walter fulcher heard many versions of many tales he has set them down as he heard them as simple folk tales that reflect the color of a wild and vivid country in 400 years of its settlement the book has been edited with introduction and notes by elton miles professor of

english at sul ross state college despite the west s growing involvement in muslim societies conflicts and cultures its inability to understand or analyze the islamic world threatens any prospect for
