and contemporary worlds and various national contexts longues durées whose presence transcends anthropological and cultural barriers divergences and discontinuities pertaining to the concept of sport are identified and explored the book also looks at the link between the rise of civilisation and the educational and training function of sport as well as the connection between a culture s decline and a growing emphasis on sport as an element of entertainment and spectacle in and of itself this book is a treasure house of italian philosophy narrating and explaining the history of italian philosophers from the middle ages to the twentieth century the author identifies the specificity peculiarity originality and novelty of italian philosophical thought in the men and women of the renaissance the vast intellectual output of the renaissance can be traced back to a single philosophical stream beginning in florence and fed by numerous converging human factors this work offers historians and philosophers a vast survey and penetrating analysis of an intellectual tradition which has heretofore remained virtually unknown to the anglophonic world of scholarship presents excavation data and pottery finds from the stratigraphy underneath the cathedral of siena the surveys were conducted between 2000 2003 the ultimate goal is to trace a view of the settlement types and economic framework that has affected the hill of the cathedral from the classical age to the late middle ages the etruscans can be shown to have made significant and in some cases perhaps the first technical advances in the central and northern mediterranean to the etruscan people we can attribute such developments as the tie beam truss in large wooden structures surveying and engineering drainage and water tunnels the development of the foresail for fast long distance sailing vessels fine techniques of metal production and other pyrotechnology post mortem c sections in medicine and more in art many technical and iconographic developments although they certainly happened first in greece or the near east are first seen in extant etruscan works preserved in the lavish tombs and goods of etruscan aristocrats these include early portraiture the first full length painted portrait the first perspective view of a human figure in monumental art specialized techniques of bronze casting and reduction fired pottery the bucchero phenomenon etruscan contacts through trade treaty and intermarriage linked their culture with sardinia corsica and sicily with the italic tribes of the peninsula and with the near eastern kingdoms greece and the greek colonial world iberia gaul and the punic network of north africa and influenced the cultures of northern europe in the past fifteen years striking advances have been made in scholarship and research techniques for etruscan studies archaeological and scientific discoveries have changed our picture of the etruscans and furnished us with new specialized information

thanks to the work of dozens of international scholars it is now possible to discuss topics of interest that could never before be researched such as etruscan mining and metallurgy textile production foods and agriculture in this volume over 60 experts provide insights into all these aspects of etruscan culture and more with many contributions available in english for the first time to allow the reader access to research that may not otherwise be available to them lavishly illustrated the etruscan world brings to life the culture and material past of the etruscans and highlights key points of development in research making it essential reading for researchers academics and students of this fascinating civilization focusing on the way bishops in the eleventh century used the ecclesiastical tithe church taxes to develop or re order ties of loyalty and dependence within their dioceses this book offers a new perspective on episcopacy in medieval germany and italy using three broad case studies from the dioceses of mainz salzburg and lucca in tuscany john eldevik places the social dynamics of collecting the church tithe within current debates about religious reform social change and the so called feudal revolution in the eleventh century and analyses a key economic institution the medieval tithe as a social and political phenomenon by examining episcopal churches and their possessions not in institutional terms but as social networks which bishops were obliged to negotiate and construct over time using legal historiographical and interpersonal means this comparative study casts fresh light on the history of early medieval society italia civiltà e cultura offers a comprehensive description of historical and cultural development on the italian peninsula this project was developed to provide students and professors with a flexible and easy to read reference book about italian civilization and cultural studies also appropriate for cinema and italian literature classes this text is intended for students pursuing a minor or a major in italian studies and serves as an important learning tool with its all inclusive vision of italy each chapter includes thematic itineraries to promote active class discussion and textual comprehension check questions to guide students through the reading and understanding of the subject matter this title focuses on an italian architect and engraver of the 18th century piranesi in this book it is argued that piranesi grants a metaphorical meaning to the carceri a set of etchings in order to imprison those he saw as obstructing the arts and threatening his own freedom in light of the growing academic interest in italy and the re organization of many university courses in italian this series aims to bring together different scholarly perspectives on italy and its culture the refreshed insights into early imperial roman historiography this book offers are linked to a recent discovery in the spring of 2014 the binders of the archive of robert marichal were dusted off by the erc funded project

platinum erc stg 2014 n 636983 in response to tiziano dorandi s recollections of a series of unpublished notes on latin texts on papyrus among these was an in progress edition of the latin rolls from herculaneum together with marichal s intuition that one of them had to be ascribed to a certain annaeus seneca platinum followed the unpublished intuition by robert marichal as one path of investigation in its own research and work working on the latin p herc 1067 led to confirm marichal s intuitions and to go beyond it p herc 1067 is the only extant direct witness to seneca the elder s historiae bringing a new and important chapter of latin literature arise out of a charred papyrus is significant the present volume is made up of two complementary sections each of which contains seven contributions they are in close dialogue with each other as looking at the same literary matter from several points of view yields undeniable advantages and represents an innovative and fruitful step in latin literary criticism these two sections express the two different but interlinked axes along which the contributions were developed on one side the focus is on the starting point of the debate namely the discovery of the papyrus roll transmitting the historiae of seneca the elder and how such a discovery can be integrated with prior knowledge about this historiographical work on the other side there is a broader view on early imperial roman historiography to which the new perspectives opened by the rediscovery of seneca the elder s historiae greatly contribute surveying the development of medieval scholarship through biography this volume contains 23 original essays on scholars whose work shaped medieval historiography for the past 300 years their subject was europe between 500 and 1500 and they labored to define that protean and multinational culture each of them pioneered or revolutionized traditional views on fields such as diplomatics mabillon economic social and constitutional history power pirenne bloch stubbs waitz whitelock maitland manuscript and archival studies delisle muratori jewish history and the history of islam and byzantium von grunebaum ostrogorsky symbology and intellectual history kantorowicz schramm smalley general and cultural history gibbon adams haskins s nchez albornoz and ecclesiastical history bolland lea and the history of magic and science thorndike some of the scholars pioneered comparative and interdisciplinary studies all published work that is still essential to our understanding of the past and more important the present the fourth volume of the new cambridge medieval history covers the eleventh and twelfth centuries which comprised perhaps the most dynamic period in the european middle ages this is a history of europe but the continent is interpreted widely to include the near east and north africa the volume is divided into two parts of which this the second deals with the course of events ecclesiastical

and secular and major developments in an age marked by the transformation of the position of the papacy in a process fuelled by a radical reformation of the church the decline of the western and eastern empires the rise of western kingdoms and italian elites and the development of governmental structures the beginnings of the recovery of spain from the moors and the establishment of western settlements in the eastern mediterranean region in the wake of the crusades 1250 224 despite an outpouring in recent years of history and cultural criticism related to the holocaust italian women s literary representations and testimonies have not received their proper due this project fills this gap by analyzing italian women s writing from a variety of genres all set against a complex historical backdrop
