research shows that 83 5 of nursing home residents are aged 65 years and older with 71 5 of them having hypertension 47 8 having dementia and 46 3 having clinical depression 7 compared to those living in community dwellings nursing home residents face moderately higher overall disease burden nursing home residents have lower reported
